Description of the discussion point

- SCANOSS has reached out, so STF evaluates the possibility of hosting the following open data sets.
 - [Purl2cpe](#)
 - [Crypto algorithms open data set](#)
- This might be the starting point of a stream of open data sets created at STF by SCANOSS
- To evaluate such an idea, which requirements does STF have?
 - Legal requirements
 - Which requirements should developers meet to participate?
 - CoC
 - Which requirement should be met to host a new data set?
 - Financial requirements
 - Those who bring data sets.... do they need to become members?
 - Technical requirements
 - Process requirements
 - How to get the permissions granted
 - Step 1: fill and sign a document. Send it to a specific mail. Get confirmation of reception, approval, create account, the user creates a password for the account
 - Step 2: add the form to the website and a mail to send it
 - Step 3: implement the process on the website

STF online decision-making process – discussion

Proposal for discussion from Agustin. Description



To speed up things for STF and take advantage of our remote nature, STF want to define a decision-making process that could be taken online in the first instance and then consolidated in a Governing Board meeting.

Such decision-making process will be part of the STF Internal Rules document, defined by the Charter as *“Internal Rules: documents created, maintained, and implemented by the Software Transparency Foundation’s Governing Bodies to manage and regulate specific aspects of the Foundation’s operations and governance, not explicitly defined in this Charter. These rules may expand upon or detail the provisions described within the Charter, providing guidelines, procedures, and policies to support the effective functioning and governance of the Foundation.”*

The core principles for that decision-making process are:

- The online decision-making process will only be applicable to operational decisions.
 - If any Governing Board Member Representative shows concerns about the operational nature of the decision being proposed, the motion will be considered invalid. The motion should be taken to the Governing Board Meeting.
- The motion will be confirmed in the following Governing Board meeting. Otherwise, it will not be valid
- Only Governing Board Member Representatives can propose a motion subject of approval through an online decision-making process.
- Only Governing Board Member Representatives will have the right to vote online.
- For the online motion to be approved every Governing Board Member should vote affirmatively, with an explicit sentence that leaves no room for interpretation.
- As soon as any Governing Board Member Representative makes a comment, clarification or shows any concern during the voting, the motion will be considered invalid.
- The online decision-making process to propose and approve operational related motions will take place through the STF general mailing list st-foundation@freelists.org
- The motion will be proposed in a single mail with a clear subject including the words “online motion”.
 - Ideally, the motion will have a rationale, a description and a specific section where the decision to take is clearly described.
